Terms of reference of the Nomination Committee (the "Committee") of the Board (the "Board") of Directors (the "Directors") of the Company 本公司董事(「董事 |) 會(「董事會 |) 提名委員會(「委員會 |) 職權範圍

1. Constitution

1.1 The Committee is established pursuant to a resolution passed by the Board at its meeting held on June 23, 2018.

組成

本委員會乃根據董事會於2018年6月23日 舉行的會議通過的決議案成立。

2. Membership

2.1 Members of the Committee shall be appointed by the Board from amongst the Directors and shall consist of not less than three members and a majority of whom shall be independent non-executive Directors.

成員

委員會成員由董事會從董事中挑選,委 員會人數最少三名,而大部份之成員須 為獨立非執行董事。

2.2 The Chairman of the Committee shall be appointed by the Board or elected among the members of the Committee which shall be the chairman of the Board or an independent non-executive Director.

委員會主席由董事會委任或經委員會成 員 選舉,並由董事會主席或獨立非執行 董事擔任主席。

2.3 The company secretary of the Company shall be the secretary of the Committee. In the absence of the secretary of the Committee, Committee members present at the meeting may elect among themselves or appoint another person as the secretary for that meeting.

本公司的公司秘書為委員會的秘書。如 委員會秘書缺席,出席委員會會議的成 員,可互選或委任其他人擔任該會議的 秘書。 2.4 The appointment of the members of the Committee may be revoked, replaced or additional members may be appointed to the Committee by separate resolutions passed by the Board and by the Committee. An appointment of Committee member shall be automatically revoked if such member ceases to be a member of the Board.

3. Procedural Standing Orders

- 3.1 The Standing Orders which from time to time apply to the terms of reference of the Audit Committee of the Board shall apply *mutatis mutandis* to these terms of reference of the Committee.

3.2 Meetings shall be held at least once annually or more frequently if circumstances require.

5. Authority of the Committee

- 5.1 The Committee may exercise the following powers:

- (a) to seek any information it requires from any employee of the Company and its subsidiaries (hereinafter collectively referred to as "Group") and any professional advisers, to require any of them to prepare and submit reports and to attend Committee meetings and to supply information and address the questions raised by the Committee;
- (a) 向本公司及其附屬公司(合稱「本集 團」)的任何僱員及任何專業顧問索 取其所需的資料、要求上述人士準 備及提交報告、出席委員會會議並 提供所需資料及解答委員會提出的 問題;
- (b) to review the performance of the Directors and the independence of independent non-executive Directors in relation to their appointment or re-appointment as Directors;
- (b) 就董事的委任或重新委任,評審有 關董事的表現及有關獨立非執行董 事的獨立性;

- to obtain, at the Company's expenses, outside legal or other independent professional advice for the purpose of performing its duties or giving assistance to any matters within these terms of reference, including the advice of independent human resource consultancy firm or other independent professionals, and to secure the attendance of outsiders with relevant experience and expertise at its meetings as it considers necessary. The Committee shall have full authority to commission any search (including without limitation litigation, bankruptcy and credit searches), report, survey or open recruitment which it deems necessary to help it fulfill its duties and should be provided with sufficient resources to discharge its duties;

- (d) to review annually these terms of reference and their effectiveness in the discharge of its duties and to make recommendation to the Board any changes it considers necessary; and

- (e) to exercise such powers as the Committee may consider necessary and expedient so that their duties under section 6 below can be properly discharged.

- 5.2 The Company should provide the Committee with sufficient resources to perform its duties.

6. Duties of the Committee

委員會的職責

6.1 The duties of the Committee shall be:

- (a) to review the structure, size and composition (including the skills, knowledge, experience and diversity of perspectives) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- (a) 至少每年檢討董事會的架構、人數 及組成(包括技能、知識、經驗及多 元化觀點),並就任何為配合本公司 策略而擬對董事會作出的變動提出 建議;
- (b) to identify individuals suitably qualified to become members of the Board and select or make recommendations to the Board on the selection of individuals nominated for directorships;
- (b) 物色具備合適資格可擔任董事的人 士,並挑選提名有關人士出任董事 或就此向董事會提供意見;
- (c) to assess the independence of the independent non-executive Directors:
- (c) 評核獨立非執行董事的獨立性;
- (d) to make recommendations to the Board on:
- (d) 向董事會提呈下列事項的建議:
- the role, responsibilities, capabilities, skills, knowledge, experience and diversity of perspectives required from members of the Board;
- (i) 作為董事會成員所應有的角色、 責任、能力、技術、知識、經 驗及多元化觀點;
- (ii) the policy on the terms of employment of non-executive Directors;
- (ii) 委聘非執行董事的政策;
- (iii) the composition of the audit committee, remuneration committee and other board committees of the Company;
- (iii) 本公司審核委員會、薪酬委員 會及其他董事會委員會的組成;

- (iv) proposed changes to the structure, size and composition of the Board:

- (v) candidates suitably qualified to become members of the Board;
- (v) 具備合適資格擔任董事的人士;
- (vi) the selection of individuals nominated for directorship;
- (vi) 挑選被提名人士出任董事;
- (vii) the re-election of any Directors who are to retire by rotation having regard to their performance and ability to continue to contribute to the Board;
- (vii) 輪流退任董事的重新委任,於此,須考慮其等的工作表現及對董事會繼續作出貢獻的能力;
- (viii) the continuation (or not) in service of any independent non-executive Director serving more than nine years and to provide recommendation to the shareholders of the Company as to how to vote in the resolution approving the re-election of such independent non-executive Director;
- (viii)在任多於九年的獨立非執行董 事的去留問題,並就該等獨立 非執行董事的重選向本公司股 東就審議有關決議案如何投票 提供建議;

- (ix) the appointment or re-appointment of Directors;
- (ix) 董事委任或重新委任董事;
- (x) succession planning for Directors in particular the chairman and the chief executive; and
- (x) 董事繼任計劃(尤其是主席及行 政總裁);及

- (xi) the policy concerning the diversity of Board members, and the measurable objectives for implementing such policy and to discuss with the Board any revisions that may be required, and recommend any such revisions to the Board for consideration and approval;
- (xi) 關於董事會成員多元化的政策, 執行該政策的可衡量目標,以 及與董事會討論任何需對該政 策作出的修訂,並向董事會提 出修訂建議,供董事會考慮及 通過;
- (e) to give full consideration to the following in the discharge of its duties as mentioned above or elsewhere in these terms of reference:
- (e) 在履行上述責任或本職權範圍項下的其他責任,對下列各項給予充份 考慮:
- (i) succession planning of Directors;
- (i) 董事接替計劃;
- (ii) leadership needs of the Group with a view of maintaining or fostering the competitive edge of the Group over others;
- (ii) 為保持或加強本集團的競爭優勢所需要的領導才能;
- (iii) changes in market environment and commercial needs of the market in which the Group operates;
- (iii) 市場環境的轉變及本集團營運 市場的商業需要;
- (iv) the skills and expertise required from members of the Board:
- (iv) 董事會成員所須具備的技能及 專才;
- (v) the Board's policy concerning diversity of Board members adopted from time to time; and
- (v) 由董事會不時採納的關於董事 會成員多元化的政策;及

- (vi) the relevant requirements of the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") with regard to directors of a listed issuer;
- (vi) 香港聯合交易所有限公司(「聯交所」) 證券上市規則(「上市規則)) 對上市發行人的董事的相關要求;

- (f) in respect of any proposed service contracts to be entered into by any members of the Group with its director or proposed director, which require the prior approval of the shareholders of the Company at general meeting under rule 13.68 of the Listing Rules, to review and provide recommendations to the shareholders of the Company (other than shareholders who are directors with a material interest in the relevant service contracts) as to whether the terms of the service contracts are fair and reasonable and whether such service contracts are in the interests of the Company and the shareholders as a whole, and to advise shareholders on how to vote;
- (f) 就任何按上市規則第13.68條須事先 取得本公司股東批准的現任董事或 侯任董事與本集團任何成員的擬定 服務合同作出審閱,並就該擬定服 務合同條款的公平及合理性、服務 合同對本公司及整體股東而言是否 有利及本公司股東應怎樣作表決等 向本公司股東提呈建議(不包括該等 股東亦同時為於相關服務合同有重 大利益的董事);

- (g) to ensure that on appointment to the Board, non-executive Directors receive a formal letter of appointment setting out what is expected of them in terms of time commitment, committee service scope and involvement outside meetings of the Board;
- (g) 確保每位被委任的非執行董事於被 委任時均取得正式委任函件,當中 須訂明對其等之要求,包括工作時 間、委員會服務範圍及參與董事會 會議以外的工作;

- (h) to conduct exit interviews with any Director upon their resignation in order to ascertain the reasons for his departure;
- (h) 會見辭去本公司董事職責的董事以 了解其離職原因;
- (i) to review the policy on Board diversity, as appropriate, to ensure its effectiveness and the measurable objectives for implementing such policy from time to time adopted by the Board, and to review the progress on achieving these objectives on an annual basis;
- (i) 為確保董事會成員多元化政策行之 有效,於適當時候檢討該政策及為 執行由董事會不時採納的有關政策 的可衡量目標,以及每年檢討達成 該等目標的進度;
- (j) to report annually, in the corporate governance report contained in the Company's annual report, on the Board's composition under diversified perspectives, and monitor the implementation of the Board diversity policy; and
- (j) 於每年在本公司年報刊載的《企業管 治報告》內匯報董事會依據多元化層 面的組合,並監察董事會成員多元 化政策的執行;及
- (k) to consider and implement other matters, as defined or assigned by the Board or otherwise required by the Listing Rules from time to time.
- (k) 考慮及執行董事會不時界定或委派 或上市規則不時規定的其他事項。

7. Annual general meeting

股東週年大會

7.1 The Chairman of the Committee or in his absence, another member of the Committee or failing this, his duly appointed delegate, shall attend the annual general meeting of the Company and be prepared to answer questions at the annual general meeting on the Committee's activities and their responsibilities.

8. Continuing application of the articles of association of the Company

本公司組織章程的持續適用

8.1 The articles of association of the Company regulating the meetings and proceedings of the Directors so far as the same are applicable and are not replaced by the provisions in these terms of reference shall apply to the meetings and proceedings of the Committee.

9. Powers of the Board

董事會權力

The Board may, subject to compliance 9.1 with the articles of association of the Company and the Listing Rules (including the Corporate Governance Code set out in Appendix 14 to the Listing Rules or if adopted by the Company, the Company's own code of corporate governance practices), amend, supplement and revoke these terms of reference and any resolution passed by the Committee provided that no amendments or supplements to and revocation of these terms of reference and the resolutions passed by the Committee shall invalidate any prior act and resolution of the Committee which would have been valid if such terms of reference or resolution had not been amended, supplemented or revoked.

本職權範圍所有規則及委員會通過的決議,可以由董事會在不違反公司章程及上市規則的前提下(包括上市規則之一時之下規則的前提下(包括上市規則之一,可以企業管治守則》或本公司自行制定的企業管治常規守則(如被採用)),隨時修訂、補充及廢除,惟有關修訂、補充及廢除,並不影響任何在有關行動作出前,委員會已經通過的決議或已採取的行動的有效性。

10. Publication of the terms of 委員會職權範圍的刊登 reference of the Committee

10.1 The Committee should make available its terms of reference, explaining its role and the authority delegated to it by the Board by including them on the website of the Company and on the website of the Stock Exchange.
